

## Public Procurement Thresholds – 11 December 2023

### 1. National Procurement Thresholds (Below EU Threshold)

The National Procurement thresholds (Below EU Threshold) for advertising and the procurement procedures to be used are set out below.

Note: Where Grant Recipients are required to comply with public procurement procedures it should be noted that the funding body may require additional conditions to be met for the grant funding, and this is a matter for the funding body to inform the applicant of same.

### **2. Thresholds (exclusive of VAT) above which advertising of contracts in the Official Journal of the EU is obligatory, applicable from 1 January 2024 (until 31 December 2025) and on e-Tenders:**

The main advertising thresholds with effect **from 1 January 2024** are as follows:

<p><b>Works</b> - €5,538,000 Government Departments and Offices, Local and Regional Authorities and public bodies</p> <p><b>Supplies and Services</b> €143,000 - Government Departments and Offices €221,000 - Local and Regional Authorities and public bodies outside the Utilities sector €750,000 – light touch regime - social and other specific services listed in Annex XIV of the EU Directive 2014/24/EU.</p> <p><b>Utilities (for entities in Utilities sector covered by GPA)</b> Works Contracts - €5,538,000 Supplies and Services - €443,000</p>
